

JAIN CENTER OF GREATER PHOENIX (JCGP) 2011 RAFFLE RULES & REGULATIONS

ELIGIBILITY: Entry purchaser must be either a business entity or an individual 21 years or older at time of entry purchase. All federal, state and local laws and regulations apply. Entries may be purchased directly or through designated representative(s). Questions concerning raffle ticket should be directed to the "Administrator," Jain Center of Greater Phoenix, at the address listed below. By entering the Raffle, the entry purchaser acknowledges that he or she is aware of, and agrees to abide by, the Raffle's rules and regulations.

DRAWING: Draw date: September 5th 2011. All entries are non-refundable. All draws will be under the supervision of the Administrator. JCGP reserves the right to modify the draw date beyond original draw date.

PRIZES: 3 prizes will be awarded as indicated on the ticket. The date of the ceremony to perform or dedicate the prizes will be decided by JCGP and winners will be informed accordingly and they will have to abide by the date to perform the ceremony. Depending on the ticket sales, the Jain Center of Greater Phoenix Administrator may modify the raffle ticket prizes.

- **Name Plaque at the main entrance of the temple:** location and size of the plaque will be decided by JCGP. Number of letters to be indicated by winner on the plaque will be limited to 80 letters and plaque will be in English.
- **Bhagwan Pratihtha:** JCGP will decide the idol for which Pratihtha will be done. This idol will be either in Bhamti or on the non violence monument.
- **Dharam Yatra of Temple in USA:** JCGP will create itinerary for this yatra of selected few (no more than 4) temple in USA. Winner will need to follow this itinerary of this yatra.

For each prize winner, Jain Center of Greater Phoenix will provide travel expenses (air fare from the nearest major international airport) from their hometown to Phoenix, Arizona, USA, and lodging/boarding expenses for two people during the special ceremony to be conducted at the Jain Center of Greater Phoenix temple located at 6250 S. 23rd Avenue, Phoenix, Arizona, USA for the dedication of prizes. It will be winner's responsibility to secure visa and/or appropriate travel document as well as medical insurance. Winners will be responsible for any expenses and fees related to visa/travel documents and medical insurance or medical expense. Person whose name appears on the winning ticket should be one of the person traveling.

NOTIFICATION OF WINNERS: All winners will be notified via courier, mail, or by email where available, by the Administrator to claim the prize.

Jain Center of Greater Phoenix's Administrator is responsible for resolving disputes which may arise from any conflict regarding the raffle ticket prize winners. The Administrator's decision will be deemed final.
